





ISSUE AGREEMENT

This ISSUE AGREEMENT ("Agreement") is entered into on day of July 27, 2024 at Gujarat between Hamps Bio Limited a company incorporated under the Companies Act, 2013 having its registered office at 2900/112, GIDC, Near Atul Limited, Ankleshwar, Bharuch – 393 002, Gujarat, India (hereinafter referred as "HBL" or "Is suer" or "The Company", which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include its successors and permitted assigns), of the FIRST PART;

AND

MARWADI CHANDARANA INTERMEDIARIES BROKERS PRIVATE LIMITED, a company incorporated under Companies Act, 2013 and having SEBI registration number INM000013165 and having its registered office at X-change Plaza, Office no. 1201 to 1205, 12th Floor, Building No. 53E, Zone-5, Road 5E, Gift City, Gandhinagar - 382355, Gujarat, India (hereinafter referred to as "MCIBPL" or "Lead Manager" or "LM", which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include its successors and permitted assigns).

In this Agreement, the Company and the LM are collectively referred to as the "Parties" and individually as a "Party".

WHEREAS:

- The Issuer is proposing an initial public offering of up to [●] equity shares of face value ₹[●] 10 each aggregating to ₹ 650.00 Lakhs of the Issuer ("Equity Shares" and such proposed issue, the "Issue"), through the fixed price method ("Fixed Price"), as prescribed in the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended from time to time ("SEBI ICDR Regulations"), at a price as may be decided by the Issuer in consultation with the Lead Manager ("Issue Price"); in accordance with the Companies Act as defined herein, the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended, (the "SEBI ICDR Regulations") and other applicable laws, at such price as may be determined through the fixed price issue process under the SEBI ICDR Regulations (the "Issue Price") by the Company in consultation with the LM and/or as disclosed in Prospectus. The Issue will include eligible investors inside and outside the United States pursuant to exemptions from the registration requirements under Section 4(a) (2) and Regulation S of the U.S. Securities Act of 1933 (the "Securities Act").
- (B) The board of directors of the Company, pursuant to resolution dated April 05, 2024 and July 09, 2024 and the shareholders of the Company pursuant to resolution dated April 30, 2024 adopted in accordance with Section 62(1)(c) of the Companies Act, have approved and authorized the Issue.
- (C) The Company has approached and appointed the LM to manage the Issue, and the LM has accepted the engagement in terms of engagement letter dated July 06, 2024 (the "Engagement Letter") subject to the terms and conditions set forth therein.
- (D) The agreed fees and expenses payable to the LM for managing the Issue are set forth in the Engagement Letter.
- (E) Pursuant to the SEBI ICDR Regulations, the LM is required to enter into this Agreement with the Company.

NOW, THEREFORE, the Parties do hereby agree as follows:





- 2.6 The Company undertakes and agrees that they shall not access the money raised in the Issue until receipt of the final listing and trading approvals from the BSE SME.  - (iii) print and electronic media controlled by a media group where the media group has a private treaty/shareholders' agreement with the Company or Promoters of the Company.

8. EXCLUSIVITY

The LM shall be the exclusive lead LM to the Company in respect of the Issue. The Company shall not, during the term of this Agreement, appoint any other lead manager, co-manager, syndicate member or other advisor in relation to the Issue without the prior written consent of the LM.
