MARKET MAKING AGREEMENT

THIS MARKET MAKING AGREEMENT MADE AT MUMBAI (INDIA) ON THIS DAY OF SEPTEMBER 03, 2024, BETWEEN:

HAMPS BIO LIMITED, company registered under provisions of the Companies Act, 1956, as amended ("Companies Act") bearing CIN: U24233GJ2007PLC049692 and having its registered office at 2900/112, GIDC, Near Atul Limited, Ankelshwar, Bharuch - 393 002, Gujarat, India (hereinafter referred to as Hamps" or "Issuer Company"), which expression shall, unless it be repugnant to the con text or meaning thereof, be deemed to mean and include its successors and permitted assigns, of the FIRST PART;

AND

MARWADI CHANDARANA INTERMEDIARIES BROKERS PRIVATE LIMITED (LM & UNDERWRITER), a Company incorporated under the Companies Act, 2013 and bearing CIN U67120GJ2018PTC103598 and having its Registered Office at X-change Plaza, Office no. 1201 to 1205, 12th Floor Building No. 53E, Zone-5, Road 5E, Gift, City, Gandhinagar, Gandhinagar, Gujarat. India, 382355 (hereinafter referred to as "Lead Manager" and "Underwriter", which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include its successors and permitted assigns) of the SECOND PART;

Pure Broking Private Limited, (Market maker) a company incorporated under Companies Act. 1956 and bearing CIN U67120GJ2013PTC098401 and having its Corporate Office at 2nd Floor. Office-201, Athwa Arcade Shopping Centre, Opp. Yatim Khana, Athwa Gate, Surat - 395001, Gujarat India and registered as a Market Maker with the SME Platform of BSE Limited (hereinafter referred to as "Pure Broker" or "Market Maker"), which expression shall, unless it be repugnant to the context or meaning thereof, be deemed to mean and include its successors and permitted assigns) of the THIRD PART.

Hamps Blo Limited, Marwadi Chandarana Intermediarles Brokers Private Limited and Pure Broking Private Limited are hereinafter collectively referred to as the "Parties" and individually as a "Party").

WHEREAS:

(A) The Issuer proposes an Initial Public Issue of 12,20,000 equity shares having face value of Rs. 10/- each (the "Offer Shares") in accordance with the Chapter IX of the SEBI (ICDR) Regulations 2018, as amended, (as defined herein) and applicable Indian securities laws for cash at a price of Rs. 51 per Equity Share (including a share premium of Rs. 41 Per Equity Share) ("Issue Price") aggregating to Rs. 622.20 Lakhs (herein after referred to as "the Issue").

- (B) The Issue comprises of 12,20,000 equity shares Of Face Value of Rs. 10/- Each ("Equity Shares") of Hamps Bio Limited ("Our Company" Or "The Issuer Company") For Cash at A Price Rs. 51 Per equity shares (Including A Share Premium of Rs. 41 Per Equity Share) ("Issue Price") Aggregating to Rs. 622.20 Lakhs ("The Issue"), Out of Which 62,000 Equity Shares of Face Value of Rs. 10/- Each for A Cash Price of Rs. 51 Per Equity Share, Aggregating to Rs. 31.62 Lakhs Will Be Reserved for Subscription by Market Maker ("Market Maker Reservation Portion"). The Issue Less the Market Maker Reservation Portion I.E. Issue of 11,58,000 Equity Shares of Face Value of Rs. 10/- Each at An Issue Price of Rs. Rs. 51 Per Equity Share Aggregating to Rs. 590.58 Lakhs (Is Hercinafter Referred to as the "Net Issue"). The Issue and the Net Issue Will Constitute 1.42 % and 26.58 %, Respectively of The Post Issue Paid Up Equity Share Capital of Our Company. The Issue will include issue within India, to institutional, non-institutional and retail investors.
- (C) The Equity Shares to be offered for allotment in this Issue comprise a Net Issue to the public of 11,58,000 Equity Shares at an Issue Price of Rs. 51 per Equity Share aggregating Rs. 590.58 Lakhs (the "Net Issue"), and a reserved portion for the Market Maker of 62,000 Equity Shares at an Issue Price of Rs. 51 per Equity Share including, aggregating Rs. 31.62 Lakhs (the "Market Maker Reservation Portion") (collectively the "Offer"). The Net Issue to public shall comprise of issue to Retail Individual Investors, Individual Applicants other than Retail Individual Investors and other investors including corporate bodies or institutions irrespective of the number of Equity Shares applied for.
- (D) The Issue shall be conducted through Fixed Price Issue pursuant to Regulation 253(2) of the SEBI (ICDR) Regulations, 2018 as amended, pursuant to which the Equity Shares are to be offered at the Issue Price of Rs. 51 per share.
- (E) The Issuer has obtained approval for the Issue pursuant to the Board resolution date April 05, 2024, July 09, 2024 and September 03, 2024. The Issuer has also obtained its shareholders' approval pursuant to Special Resolution under section 62 of Companies Act, 2013 at the meeting of its shareholders held on April 30, 2024, which collectively authorises the Company's Directors, or any other authorised representatives, for the purpose of the Issue, to issue and sign the Draft Prospectus, the Prospectus, this Agreement, the Memorandum(s) of Understanding (as defined hereunder), Underwriting Agreement (as defined hereunder), any amendments or supplements thereto, and any and all other writings as may be legally and customarily required in pursuance of the Offering and to do all acts, deeds or things as may be required.
- (F) The Issuer shall be applying for in-principal approval of BSE for listing of its Equity Shares on the Emerge Platform of BSE
- (G) Pure Broking Private Limited, Market Maker to the Issue has agreed to ensure full subscription to its Market Maker Portion of 62,000 Equity Shares in terms of this Market Making Agreement dated September 03, 2024 executed between the Issuer, the Lead Manager - Marwadi Chandarana Intermediaries Brokers Private Limited and MM - Pure Broking Private Limited
- (H) The Issuer and Underwriters have entered into an Underwriting Agreement dated September 03, 2024 pursuant to which Marwadi Chandarana Intermediaries Brokers Private Limited (Lend Manager and Underwriter) and Pure Broking Private Limited (Market Maker) have agreed to ensure that in case of any under subscription in the Net Issue of 11,58,000 Equity Shares, the same shall be arranged for subscription from its resources as per the specified timeline in terms of

the aforesaid Underwriting Agreement and in line with the requirements of the SEBI (ICDR) Regulations, 2018 (as amended from time to time) and other applicable laws, regulations and guidelines, 62,000 Equity Shares of Face Value of Rs.10/- Each for A Cash Price of Rs. 51 Per Equity Share, Aggregating to Rs. 31,62 Lakhs each for each of the Market Maker Reservation Portion which are to be subscribed by the Market Marker (Pure Broking Private Limited) in its own account in order to claim compliance with the requirements of Regulation 261 of the SEBI (ICDR) Regulations, 2018, as amended from time to time.

- (I) One of the requirements of issuing Equity Shares to the Public in accordance with the Chapter IX of the SEBI (ICDR) Regulations 2018, as amended, as specified in Regulation 261 of the said Regulations is that Marwadi Chandarana Intermediaries Brokers Private Limited being the Lead Manager to the Issue has to ensure compulsory Market Making through the Stock Brokers of the BSE for the Compulsory Market Making Period (as defined hereinafter).
- (J) Pure Broking Private Limited is a Registered Stock Broker/Trading Member of BSE having SEB! Registration No INZ000163631. Subsequently it is registered as a Market Maker and can act as
- (K) The Issuer- Hamps Bio Limited and Lead Manager- Marwadi Chandarana Intermediaries Brokers Private Limited have approached Pure Broking Private Limited (MM Name) for being appointed as Market Maker for this Initial Public Issue and (MM NAME) has accepted such proposal and confirmed that there is no conflict of interest arising from such transaction or arrangement. The Issuer has understood the preliminary arrangements in place and agreed to such appointment and these parties have now therefore agreed to enter into this agreement for the relevant business.

NOW THEREFORE IT IS HEREBY AGREED BY AND AMONG THE PARTIES

1. DEFINITIONS AND INTERPRETATIONS

1.1 In addition to the defined terms contained elsewhere in this Agreement, the following expressions, as used in this Agreement, shall have the respective meanings set forth below:

"Affiliate" with respect to a specified person, shall mean any other person that directly, or indirectly through one or more intermediaries, controls or is controlled by, or is under common control with, the specified person.

"Allotment" shall mean the issue and allotment of Offer Shares pursuant to the Offer.

"Agreement" shall mean this Agreement or any other agreement as specifically mentioned and all amendments thereto.

"Applicant" shall mean any prospective investor who makes an application pursuant to the terms of the Draft Prospectus and/or the Prospectus and the Application Form.

"Application" shall mean an indication to make an offer during the Offer Period by an ASBA Applicant, pursuant to submission of Application Form, to subscribe for or purchase Equity Shares at the Offer Price including all revisions and modifications thereto, to the extent permissible under the SEBI (ICDR) Regulations.

"BSE" shall, a recognised stock exchange having nationwide terminals, recognized by SEBI in terms of Securities Contracts (Regulation) Act, 1956.

"Party" or "Parties" shall have the meaning given to such terms in the preamble to this Agreement.

"Companies Act" shall mean the Companies Act, 2013, to the extent in force pursuant to the notification of the notified sections, read with the rules, regulations, clarifications and modifications thereunder.

"Companies Act, 1956" shall mean Companies Act, 1956 (without reference to the provisions thereof that have ceased to have effect upon notification of the notified sections of the Companies Act, 2013).

"Companies Act, 2013" shall mean Companies Act, 2013, to the extent in force pursuant to the notification of the notified sections, read with the rules, regulations, clarifications and modifications thereunder.

"Compulsory Market Making Period" shall mean the Market Making period starting from the listing of equity shares on SME Platform of BSE Limited till a minimum period of 3 (three) years as prescribed under Regulation 261 of the SEBI (ICDR) Regulations 2018, as amended. However, it has been provided that in terms of Regulation 276 of the SEBI (ICDR) Regulations, 2018, that a Company may migrate to the Main Board (in this case being the Main Board of BSE and hence for the purpose of this agreement, when a Company migrates to the main board, there is no requirement of "Market Making" and hence the Compulsory Market Making Period would be reduced to that extent.

"Controlling", "Controlled by" or "Control" shall have the same meaning ascribed to the term "control" under the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011, or as may be amended from time to time.

"Controlling Person(s)" with respect to a specified person, shall mean any other person who Controls such specified person.

"Designated Stock Exchange" shall mean BSE Limited

"Draft Prospectus" shall mean the Draft Prospectus of the Company which will be filed with BSE in accordance with Section 26 of the Companies Act, 2013 for getting in-principal listing approval.

"Indemnified Party" shall have the meaning given to such term in this Agreement and shall be read and construed in context of the text to which it pertains.

"Issue Price" means Rs. 51 per Equity Share (including a premium of Rs. 41 per equity share) of face value Rs. 10/- each.

"Listing Date" shall mean the date with effect from which the shares issued through this Offer being made by Hamps Bio Limited (issuer company name) are permitted for trading by SME platform of BSE Limited.

"Market Maker" shall mean any person who is registered as a Market Maker with the SME Platform of BSE Limited in this case being Pure Broking Private Limited (MM NAME)

"Market Maker Reservation Portion", shall mean the reserved portion of 62,000 Equity Shares of the face value of Rs. 10 each, at an Issue Price of Rs. 51 per Equity Share (including a premium of Rs. 41 per equity share) aggregating to Rs. 31.62 Lakks reserved for subscription by Market Maker.

"Material Adverse Effect" shall mean, individually or in the aggregate, a material adverse effect on the condition, financial or otherwise, or in the earnings, business, management, operations or prospects of the Issuer Company and its subsidiaries, taken as a whole.

"Memorandum(s) of Understanding" shall mean the memorandum of understanding July 27, 2024 entered between the Issuer and Lead Manager.

"Net Issue" shall mean the Fresh Issue of 11,58,000 Equity Shares of the face value of Rs. 10/each, at an Issue Price of Rs. 51 per Equity Share (including a premium of Rs. 41 per equity share) aggregating to Rs. 590.58 Lakhs.

"Non-institutional Applicants" shall mean all Applicants that are not QIBs or Retail Applicants and who have applied for Equity Shares for an amount more than Rs. 2,00,000;

"Party" or "Parties" shall have the meaning given to such terms in the preamble to this Agreement.

"Prospectus" shall mean the Prospectus of the Company which will be filed with BSE / SEBI / ROC and others in accordance with Section 26 of the Companies Act, 2013 after getting in-principal listing approval but before opening the issue.

"Qualified Institutional Buyers" or "QIBs" shall mean a qualified institutional buyer as defined under Regulation 2(1) (ss) of the SEBI (ICDR) Regulations.

"Retail Individual Investors" shall mean individual Applicants (including Hindu Undivided Family and Non-Resident Indians) who have applied for Equity Shares for an amount not more than Rs. 2,00,000 in any of the application options in the Offer.

"SEBI" shall mean the Securities and Exchange Board of India.

"SEBI (ICDR) Regulations, 2009" shall mean the SEBI (Issue of Capital and Disclosure Requirements) Regulations 2009, as amended.

"SEBI (ICDR) Regulations, 2018" shall mean the SEBI (Issue of Capital and Disclosure Requirements) Regulations 2018, as amended and as applicable to the Offering.

Platform Of BSE Limited" shall mean the separate platform for listing companies for the purpose of issuing its Equity Shares to the public in terms of Chapter IX of the SEBI (ICDR) Regulations, 2018, as amended from time to time, opened and operated by the BSE.

"Stock Exchange" shall mean recognised stock in India, i.e., BSE Limited and National Stock Exchange Limited.

a) words denoting the singular shall include the plural and vice versa;

 words denoting a person shall include an individual, corporation, Company, partnership, trust or other entity;

 headings and bold typeface are only for convenience and shall be ignored for the purposes of interpretation;

d) references to the word "include" or "including" shall be construed without limitation;

 references to this Market Making Agreement or to any other agreement, deed or other instrument shall be construed as a reference to this Market Making Agreement or such agreement, deed, or other instrument as the same may from time to time be amended, varied, supplemented or noted;

f) reference to any party to this Market Making Agreement or any other agreement or deed or other instrument shall, in the case of an individual, include his or her legal heirs, executors or

administrators and, in any other case, include its successors or permitted assigns;

g) references to a statute or statutory provision shall be construed as a reference to such provisions as from time to time amended, consolidated, modified, extended, re-enacted or replaced;

h) a reference to an article, section, paragraph or schedule is, unless indicated to the contrary, a reference to an article, section, paragraph or schedule of this Agreement;

 reference to a document includes an amendment or supplement to, or replacement or novation of, that document; and

 capitalized terms used in this Agreement and not specifically defined herein shall have the meanings given to such terms in the Draft Prospectus and the Prospectus.

1.3 The Parties acknowledge and agree that the Schedules attached hereto form an integral part of this Agreement.


2. MARKET MAKING

2.1. On the basis of the representations and warranties contained in this Agreement and subject to the terms and conditions herein, the Market Maker hereby agrees to;

A) subscribe to 62,000 equity shares being the market maker reservation portion as specified in the Draft Prospectus and Prospectus, on a firm basis and pay the amounts as are specified in the Draft Prospectus and Prospectus. The Market Maker agrees not to withdraw its application.









- B) ensure Market Making in the Equity Shares of Hamps Bio Limited in the manner and on the terms and conditions contained this Agreement, and as specified by SEBI and BSE from time to time.
- 2.2. The Market Maker(s) (individually or jointly) shall be required to provide a 2-way quote for 75% of the time in a day. The same shall be monitored by Stock Exchange. Further, the Market Maker shall inform Stock Exchange in advance for each and every black out period when the quotes are not being offered by the Market Maker.
- 2.3. The minimum depth of the quote shall be Rs.1,00,000/-. However, the investors with holdings of value less than Rs. 1,00,000/- shall be allowed to offer their holding to the Market Maker(s) (individually or jointly) in that scrip provided that he/she sells his/her entire holding in that scrip in one lot along with a declaration to the effect to the selling broker.
- 2.4. After completion of the first three months of market making, in terms of SEBI Circular No. CIR/MRD/DSA/31/2012 dated November 27, 2012; the Market Maker shall be exempt from providing buy quote on attaining the prescribed threshold limits (including the mandatory allotment of 5% of Equity Shares of the Offer). Further, the Market Maker can offer buy quotes only after the Market Maker complies with prescribed re-entry threshold limits. Only those Equity Shares which have been acquired by the Market Maker on the platform of the SME Exchange during market making process shall be counted towards the Market Maker's threshold. The Market Maker shall be required to provide two-way quotes during the first three months of the market making irrespective of the level of holding.
- 2.5. There shall be no exemption/threshold on downside. However, in the event the Market Maker exhausts its inventory through market making process, the concerned Stock Exchange may intimate the same to SEBI after due verification.
 - 2.6. The Inventory Management and Buying/Selling Quotations and its mechanism shall be as per the relevant circulars issued by SEBI and Limited from time to time.
- 2.7. Execution of the order at the quoted price and quantity must be guaranteed by the Market Maker(s), for the quotes given by them.
- 2.8. The Market Maker shall not sell in lots less than the minimum contract size allowed for trading on the SME Platform of BSE Limited (in this case currently the minimum trading lot size is 2000 Equity Shares; however, the same may be changed by the SME Platform Of BSE Limited from time to time.
- 2.9. The prices quoted by the Market Maker shall be in compliance with the Market Maker Spread requirements and other particulars as specified or as per the requirements of the SME Platform of BSE Limited and SEBI from time to time.
- 2.10. The Market Maker shall not be responsible to maintain the price of the Equity Shares of the Issuer Company at any particular level and is purely supposed to facilitate liquidity on the counter of Issuer Company via its 2-way quotes. The price of the Equity Shares shall be determined and be subject to market forces.

- 2.11. There would not be more than (5) five Market Makers for the Company's Equity Shares at any point of time and the Market Makers may compete with other Market Makers for better quotes to the investors. At this stage, Pure Broking Private Limited is acting as the sole Market Maker.
- 2.12. The Market Maker shall start providing quotes from the day of the listing / the day when designated as the Market Maker for the respective scrip and shall be subject to the guidelines laid down for market making by the SME Platform of BSE Limited.
- 2.13. On the first day of the listing, there will be pre-opening session (call auction) and there after the trading will happen as per the equity market hours. The circuits will apply from the first day of the listing on the discovered price during the pre-open call auction.
- 2.14. The Marker Maker may also be present in the opening call auction, but there is no obligation on him to do so.
- 2.15. The securities of the company will be placed in SPOS and would remain in Trade for Trade settlement for 10 days from the date of listing of Equity share on the Stock Exchange.
- 2.16. The shares of the company will be traded in continuous trading session from the time and day the company gets listed on SME Platform of BSE Limited and market maker will remain present as per the guidelines mentioned under SME Platform of BSE Limited and SEBI circulars.
- 2.17. The Market Maker has to act in that capacity for a period of three years.
- 2.18. There will be special circumstances under which the Market Maker may be allowed to withdraw temporarily / fully from the market for instance due to system problems, any other problems. All controllable reasons require prior approval from the Exchange, while force-majeure will be applicable for non-controllable reasons. The decision of the Exchange for deciding controllable and non-controllable reasons would be final.
- 2.19. The Market Maker(s) shall have the right to terminate said arrangement by giving three or one month notice or on mutually acceptable terms to the Lead Manager/Merchant Banker, who shall then be responsible to appoint a replacement Market Maker(s).
- 2.20. In case of termination of the above mentioned Market Making agreement prior to the completion of the compulsory Market Making period, it shall be the responsibility of the Lead Manager/Merchant Banker to arrange for another Market Maker(s) in replacement during the term of the notice period being served by the Market Maker but prior to the date of releasing the existing Market Maker from its duties in order to ensure compliance with the requirements of regulation 261 of the SEBI (ICDR) Regulations. Further the Company and the Lead Manager/Merchant Banker reserve the right to appoint other Market Maker(s) either as a replacement of the current Market Maker or as an additional Market Maker subject to the total number of Designated Market Makers does not exceed 5 (five) or as specified by the relevant laws and regulations applicable at that particular point of time. The Market Making Agreement is available for inspection at our Registered Office from 11.00 a.m. to 5.00 p.m. on working days.
- 2.21. Risk containment measures and monitoring for Market Makers: SME Platform of BSE Limited will have all margins which are applicable on the BSE, Main Board viz., Mark-to-Market.

Value-A(-Risk (VAR) Margin, Extreme Losa Margin, Special Margins and Base Minimum Capital etc. BSE can impose any other margins as deemed necessary from time-to-time.

- 2.22. Punitive Action in case of default by Market Makers: SMF Platform of BSE will monitor the obligations on a real time basis and punitive action will be initiated for any exceptions and / or case he is not able to provide the desired liquidity in a particular security as per the specified will impose a penaltic / fines will be set by the Exchange from time to time. The Exchange will impose a penalty on the Market Maker in case he is not present in the market Coffering two-suspension in market making activities / trading membership.
- 2.23. The Department of Surveillance and Supervision of the Exchange would decide and publish the penalties/ fines / suspension for any type of misconduct / manipulation / other irregularities by the Market Maker from time to time.
- 2.24. Price Band and Spreads: SEBI Circular bearing reference no: CIR/MRD/DP/ 02/2012 dated January 20, 2012, has faid down that for Issue size up to Rs. 250 Crores, the applicable price bands for the first day shall be:
 - In case equilibrium price is discovered in the Call Auction, the price band in the normal trading session shall be 5% of the equilibrium price.
 - In case equilibrium price is not discovered in the Call Alletion, the price band in the normal trading session shall be 5% of the Issue price.

Additionally, the trading shall take place in TFT segment for first 10 days from commencement of trading. The price band shall be 20% and the Market Maker Spread (difference between the sell and the buy quote) shall be within 10% or as intimated by Exchange from time to time.

The following spread will be applicable on the SME Exchange Platform.

2.25. Pursuant to SEBI Circular number CIR/MRD/DSA/31/2012 dated November 27, 2012, limits on the upper side for Market Makers during market making process has been made applicable, based on the Offer size and as follows:
